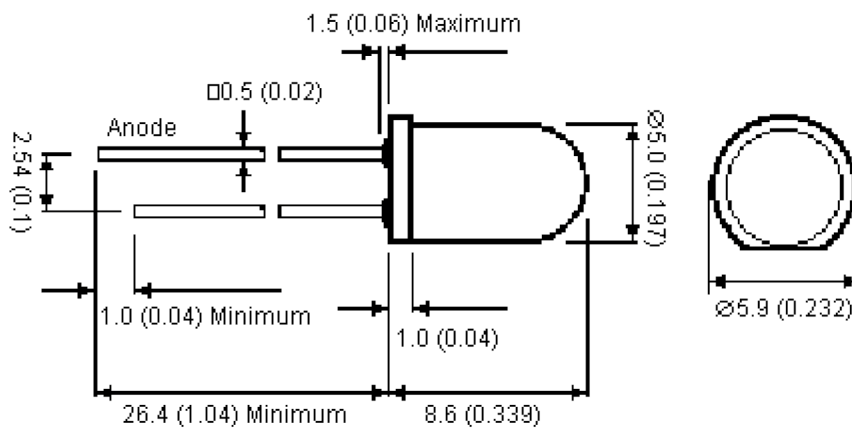
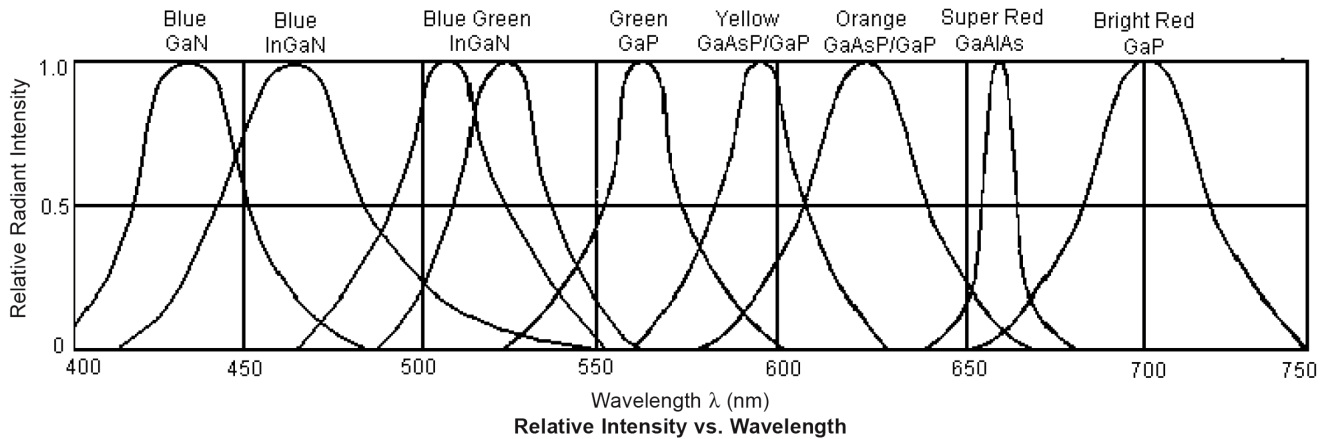


Amber (GaAsP/CaP  $\lambda_P = 610\text{nm}$ )
