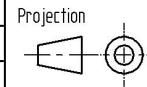

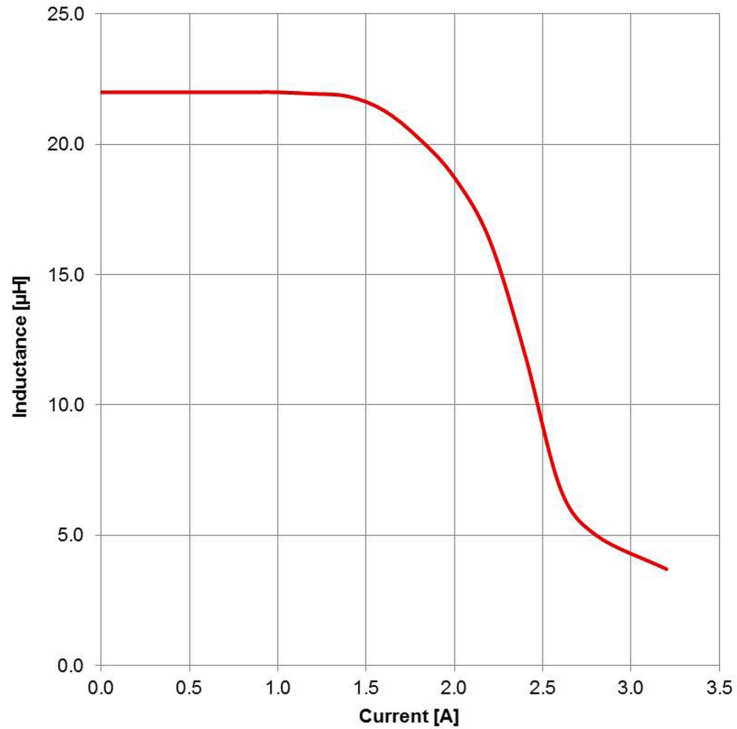

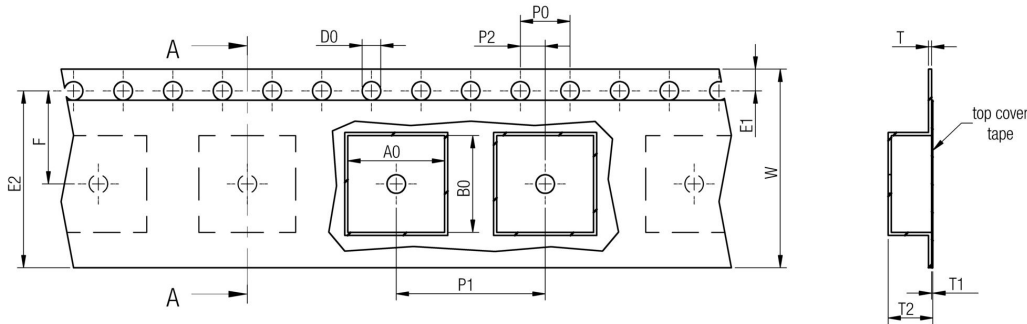
**F1 Typical Inductance vs. Current Characteristics:**

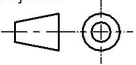

### Product specific:
