### Maximum Non-Repetitive Forward Surge Current:



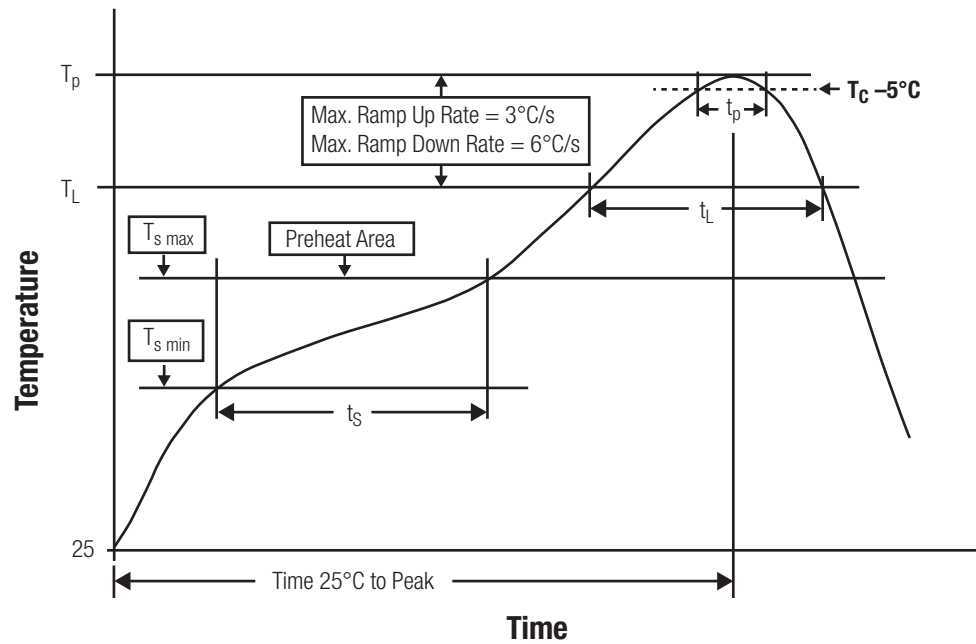
### Typical Junction Capacitance:

Signals operated continuously with a high ratio of direct-current voltage might have an influence on the product life time.




