



## **RATINGS AND CHARACTERISTICS CURVES** ( $T_A = 25$ °C unless otherwise noted)








Fig. 2 - Maximum Non-Repetitive Peak Forward Surge Current




Fig. 3 - Typical Instantaneous Forward Characteristics




Fig. 5 - Typical Junction Capacitance





Fig. 4 - Typical Reverse Characteristics
