Description of Change:

The purposes of this addendum are to correct the expected completion of the qualification from October 2016 to June 2017 and to update the list of affected parts.

Cypress announces the qualification of Cypress Philippines as an additional assembly site for select 48-Lead TSOP products.

The 48-Lead TSOP packages are assembled at Cypress Philippines using the following Bill of Materials:

Benefit of Change:

Qualification of alternate manufacturing sites is part of the ongoing flexible manufacturing initiative announced by Cypress. The goal of the flexible manufacturing initiative is to provide the means for Cypress to continue to meet delivery commitments through dynamic, changing market conditions.

Qualification Status:

This package is being qualified through a series of tests documented in the Qualification Test Plan # 163605. The qualification is expected to be completed by June 2017. Sample Status:

Please review the attached 'Affected Parts List' file for a list of affected part numbers with their associated Cypress Philippines sample ordering part numbers. Approximate Implementation Date:

Effective 90 days from the qualification completion or upon customer approval, whichever comes first, all shipments of the affected part numbers in the attached file will be assembled at Cypress Philippines or other approved assembly sites.

Anticipated Impact:

Products assembled at the new site will be completely compatible with existing products from a functional, parametric, and quality performance perspective.

Cypress also recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

Method of Identification:

Cypress maintains traceability of product to wafer level, including wafer fabrication location, through the lot number marked on the package.
