



Fig.1 Typical Capacitance vs. Drain-Source Voltage






Fig.3 Dynamic Input Characteristics





Fig.4 Typical Transfer Characteristics






Fig.5 Static Drain-Source On-State Resistance vs. Gate-Source Voltage








Fig.6 Source Current vs. Source-Drain Voltage




Static Drain-Source On-State Fig.7 Resistance vs. Drain Current (I)

DRAIN CURRENT : -I_D (A)


