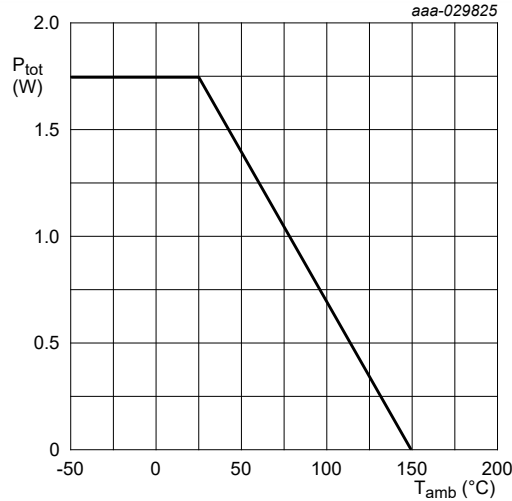

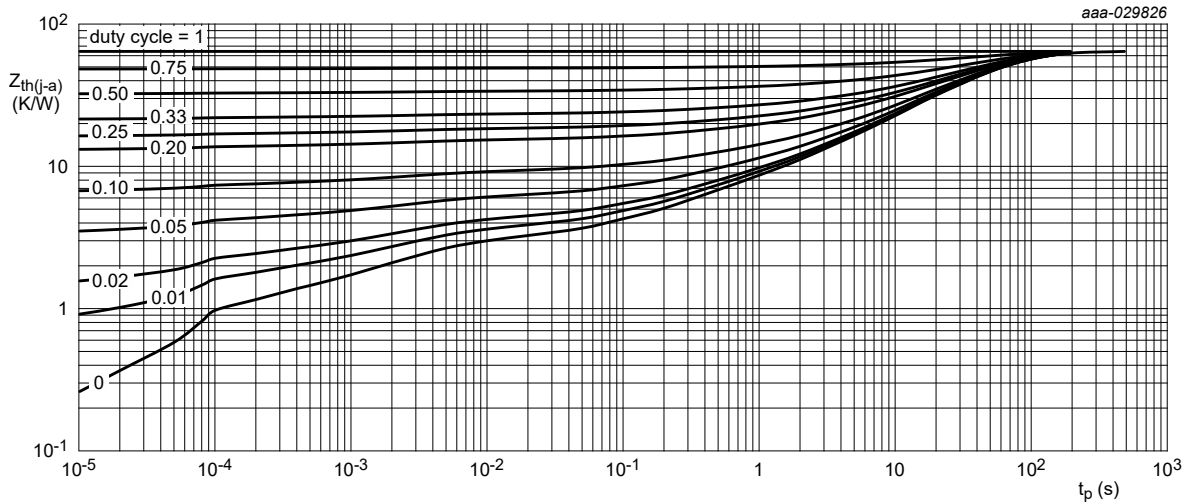
Fig. 1. Power derating curves SOT428C

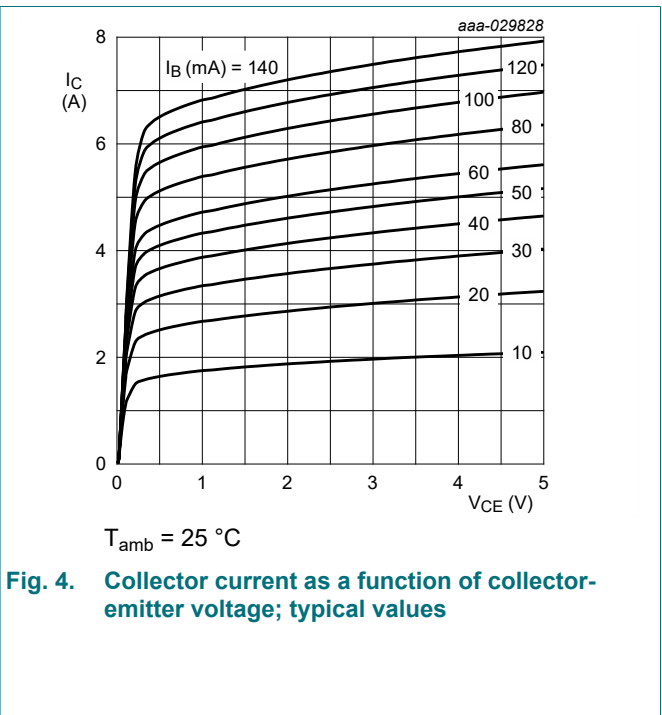
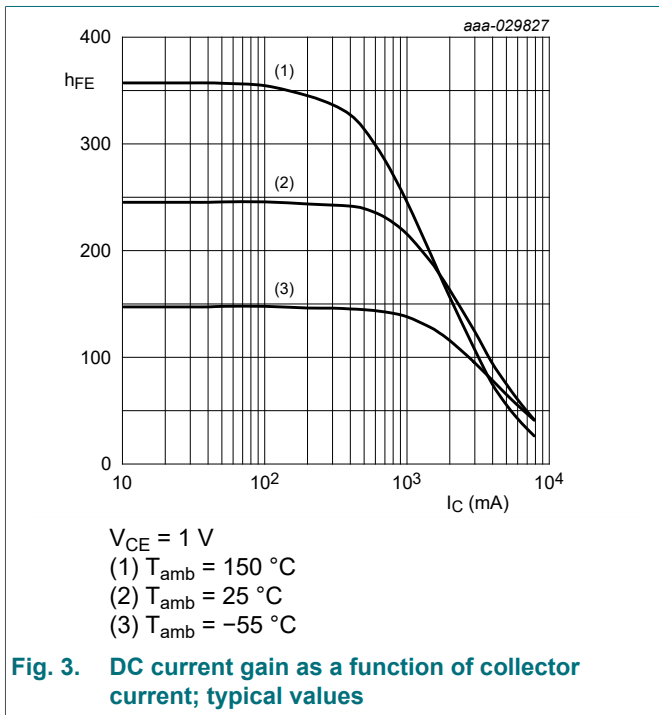
FR4 PCB, single-sided copper, tin-plated, mounting pad for collector 1 cm².

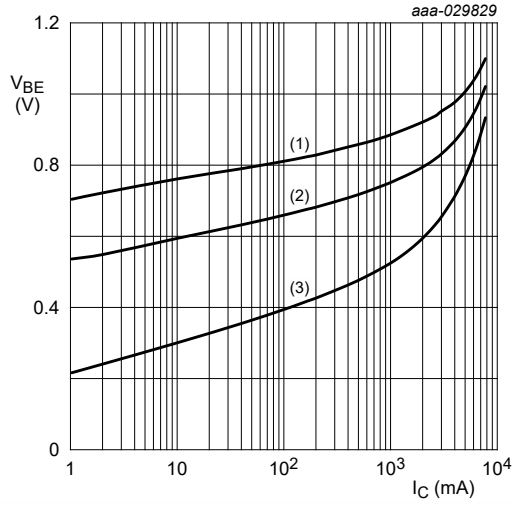
Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

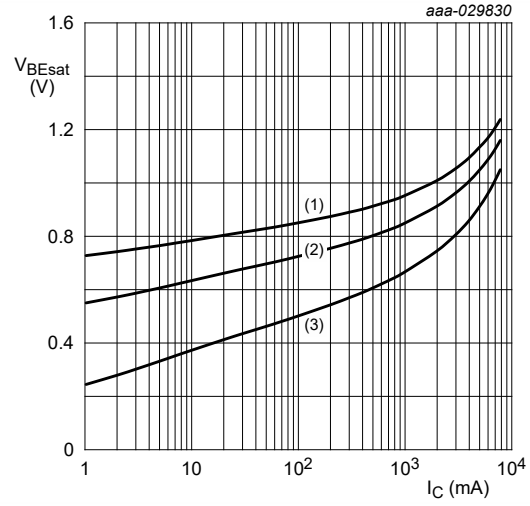

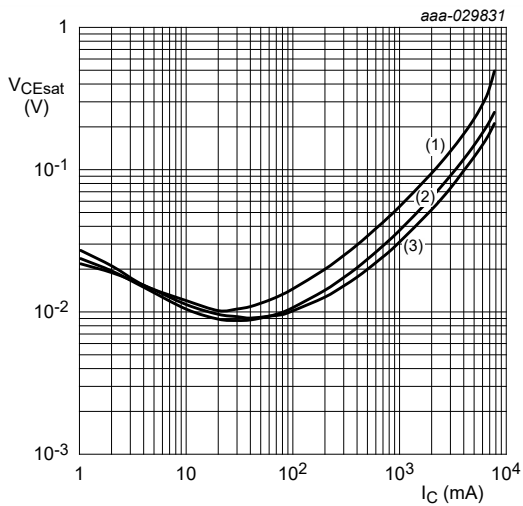

Fig. 5. Base-emitter voltage as a function of collector current; typical values



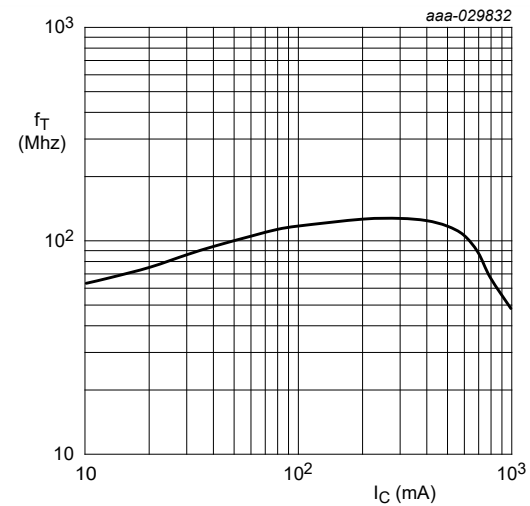

Fig. 6. Base-emitter saturation voltage as a function of collector current; typical values



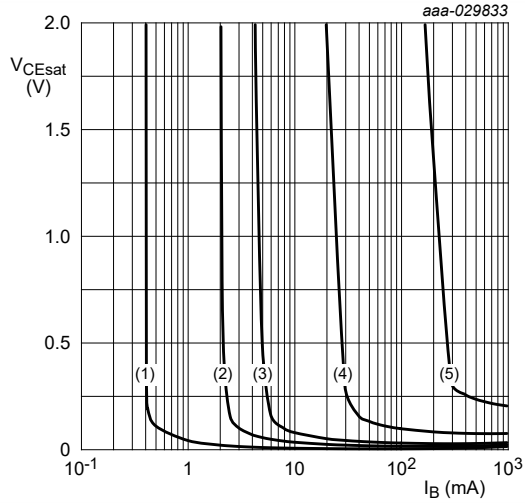

Fig. 7. Collector-emitter saturation voltage as a function of collector current; typical values



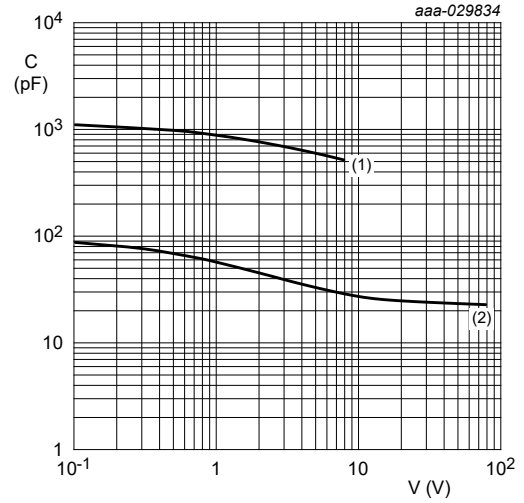

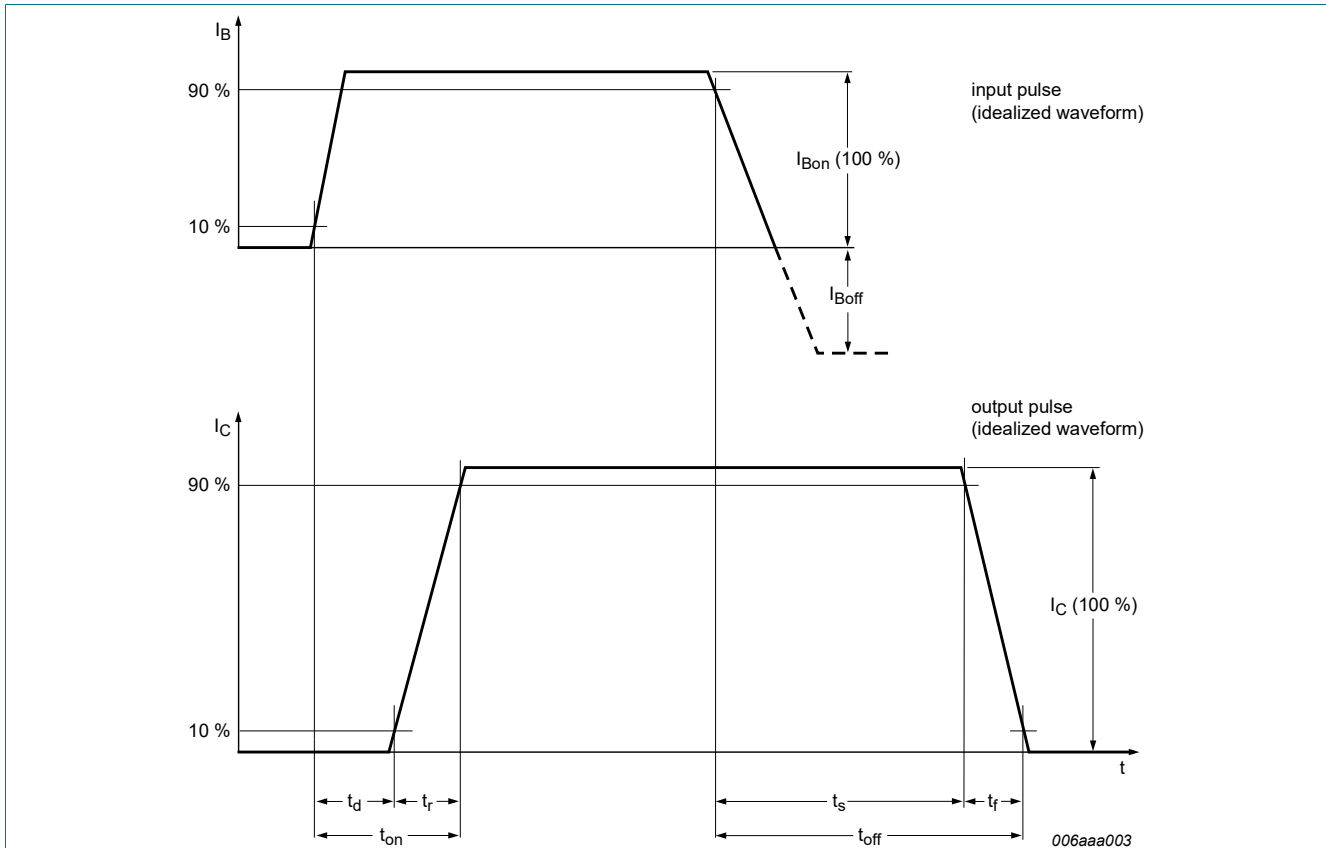


Fig. 11. BISS transistor switching time definition

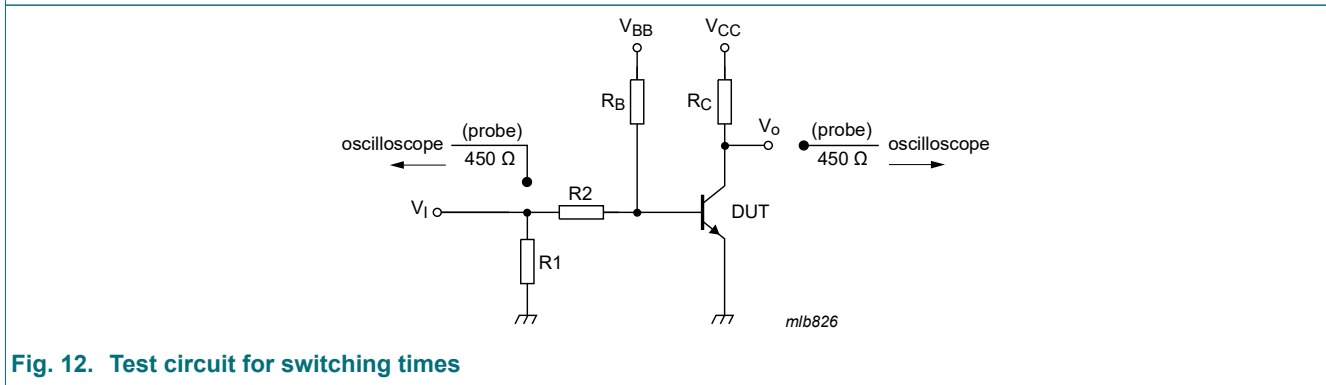


Fig. 12. Test circuit for switching times

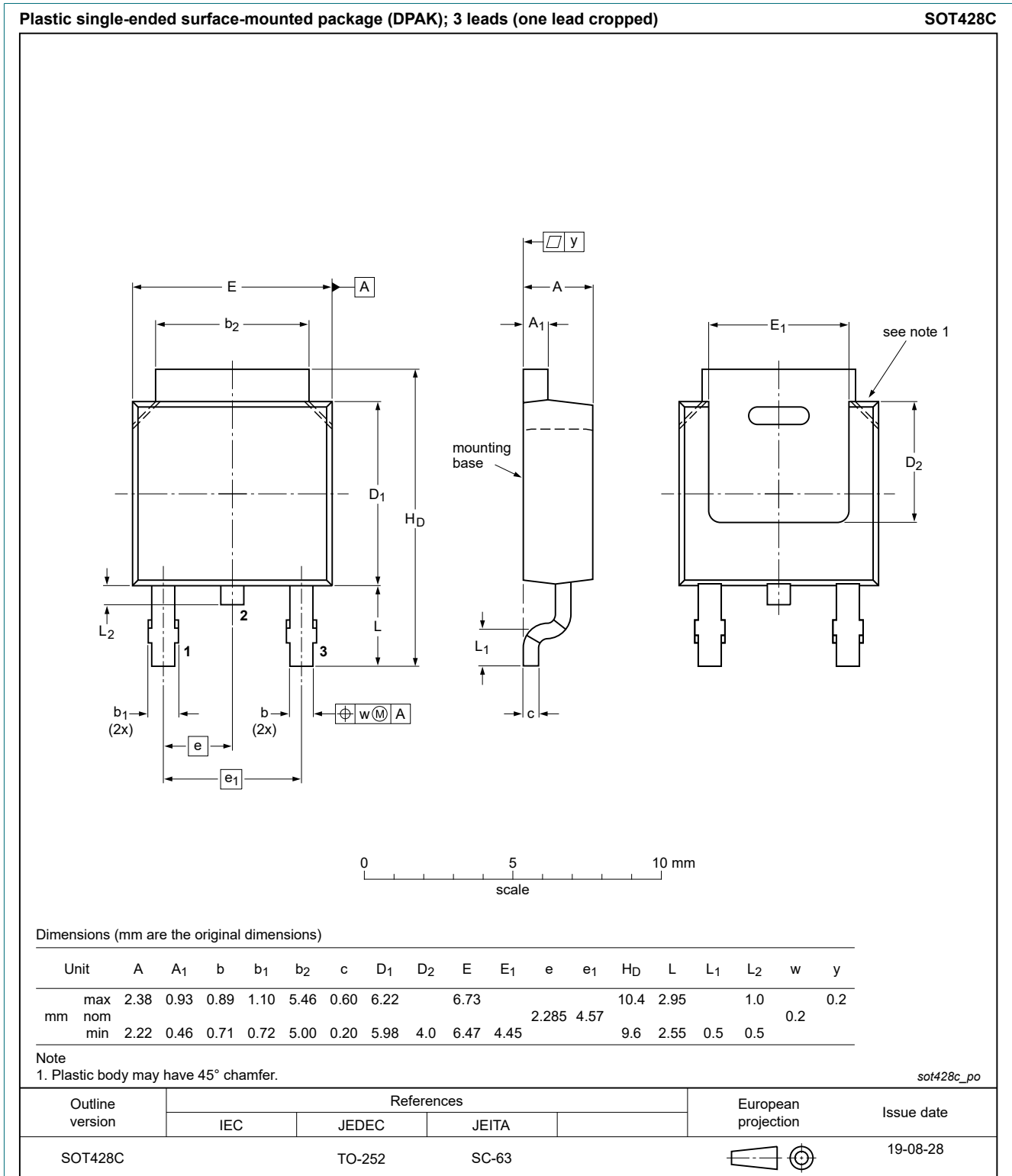


Fig. 13. Package outline DPAK (SOT428C)

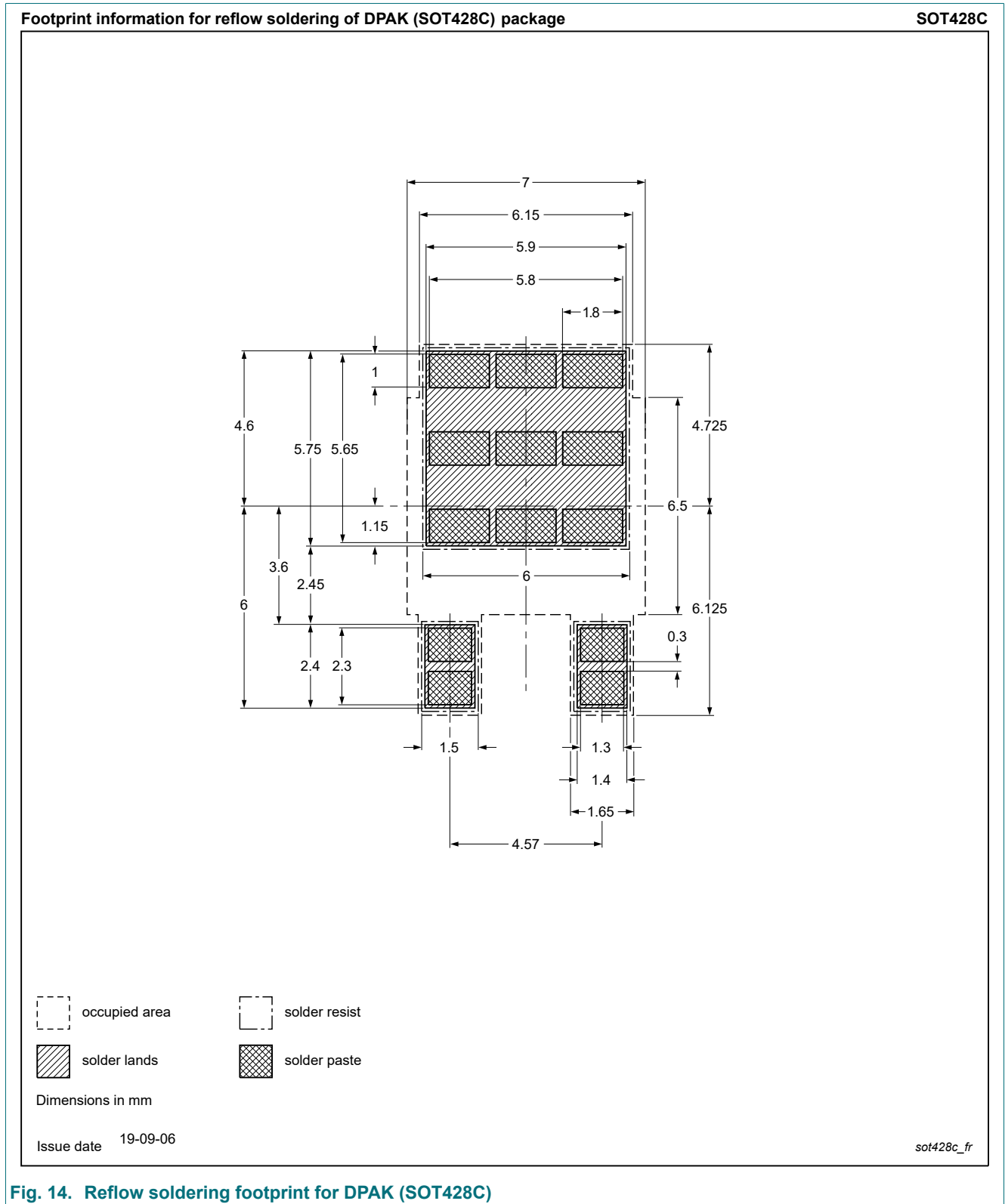


Fig. 14. Reflow soldering footprint for DPAK (SOT428C)
