

- The component is designed and manufactured to be used within the datasheet specified values. If the usage and operation conditions
  specified in the datasheet are not met, the wire insulation may be damaged or dissolved.
- Do not drop or impact the component, the component may be damaged
- Würth Elektronik products are qualified according to international standards, which are listed in each product reliability report. Würth
  Elektronik does not warrant any customer qualified product characteristics beyond Würth Elektronik's specifications, for its validity and
  sustainability over time.
- The responsibility for the applicability of the customer specific products and use in a particular customer design is always within the

#### **Product Specific:**

#### **Cleaning and Washing:**

 Washing agents used during the production to clean the customer application might damage or change the characteristics of the component, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

#### Potting:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the component. Expansion could damage the component. We recommend
a manual inspection after potting to avoid these effects.

#### Storage Conditions:

A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer
degradation, resulting in bad solderability. Therefore, all products shall be used within the period of 12 months based on the day of
shipment.

- · Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.
- Stacking height of more than seven layers is not recommended.

#### **Packaging:**

The packaging specifications apply only to purchase orders comprising whole packaging units. If the ordered quantity exceeds or is
lower than the specified packaging unit, packaging in accordance with the packaging specifications cannot be ensured.

#### Handling:

- Recommended use is between 10% and 30% material compression. Use of material beyond recommended compression rate may
  result in excessive silicone oil exudation.
- It is recommended to compress the material with equal pressure on the whole surface. Partial excessive stress may also result in
  excessive oil exudation.
- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.
