

Description

This 5 A, 100 V rectifier is based on ST trench technology that achieves the best-inclass V_F/I_R trade-off for a given silicon surface.

Integrated in a DPAK package, this STPST5H100SB-Y trench, and automotivegraded device is intended to be used in high frequency miniature switched mode power supplies such as in automotive, DC/DC converters or ECU power supply. It is also adapted to freewheeling applications, OR-ring, or reverse polarity protection.

Figure 1. Current and voltage waveforms for avalanche energy test across D.U.T (device under test)





Figure 2. Unclamped Inductive Switching Test circuit





Figure 6. Junction capacitance versus reverse voltage applied (typical values)








Figure 8. Thermal resistance junction to ambient versus copper surface under tab (typical values, epoxy printed board FR4, e_{Cu}= 70 μm)










