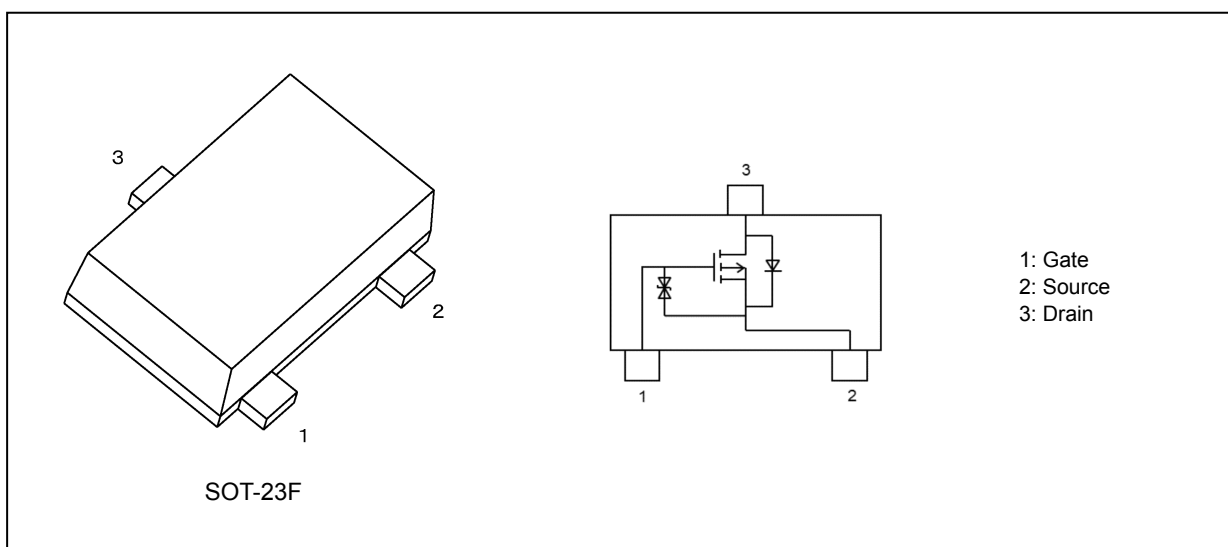

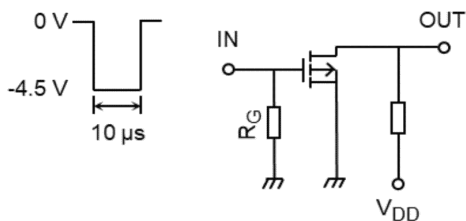


Fig. 6.3.1 Switching Time Test Circuit

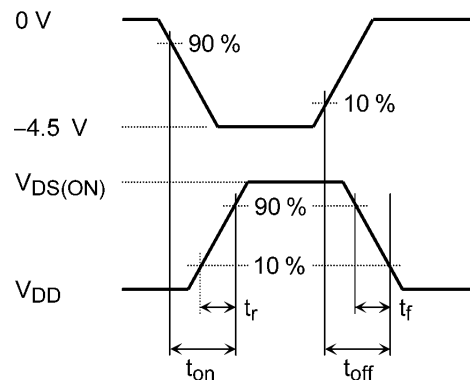


Fig. 6.3.2 Input Waveform/Output Waveform

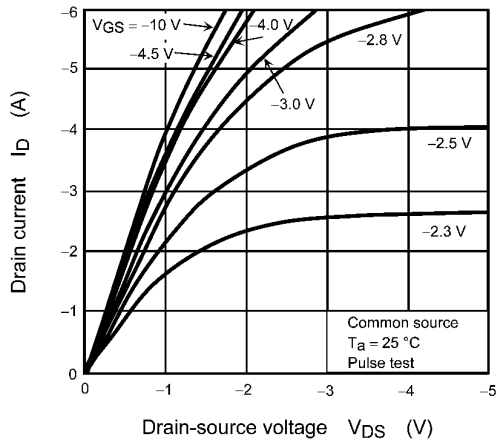

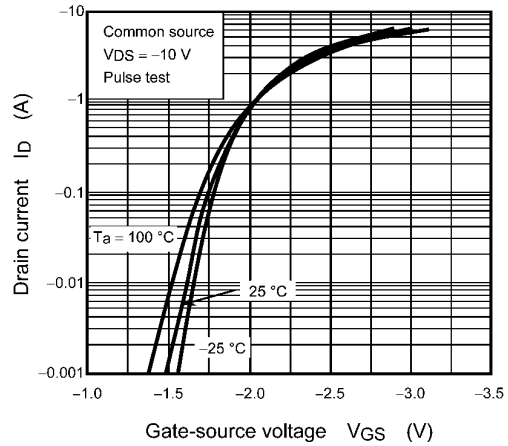

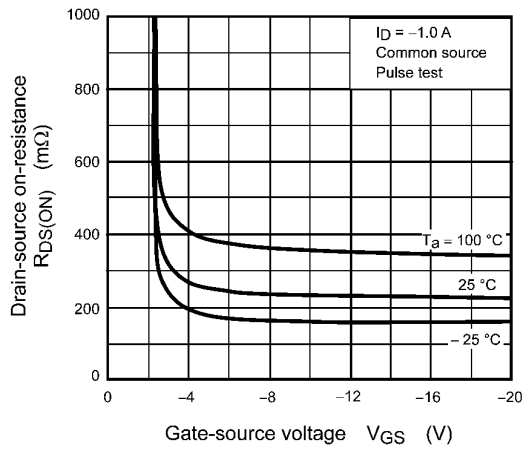

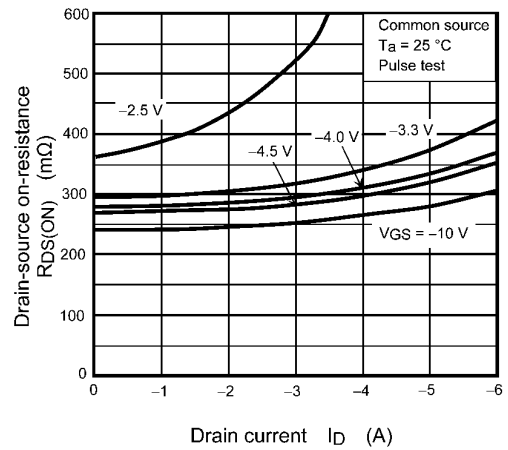
**Fig. 8.1**  $I_D - V_{DS}$



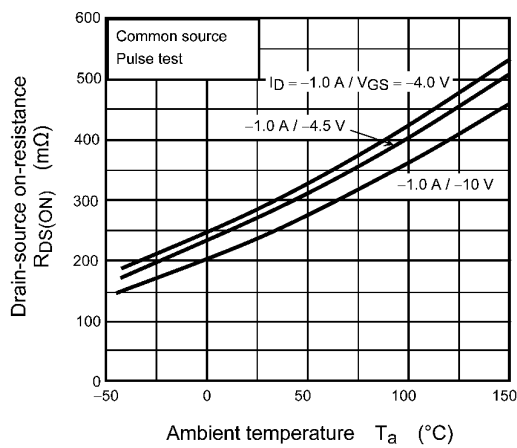
**Fig. 8.2**  $I_D - V_{GS}$



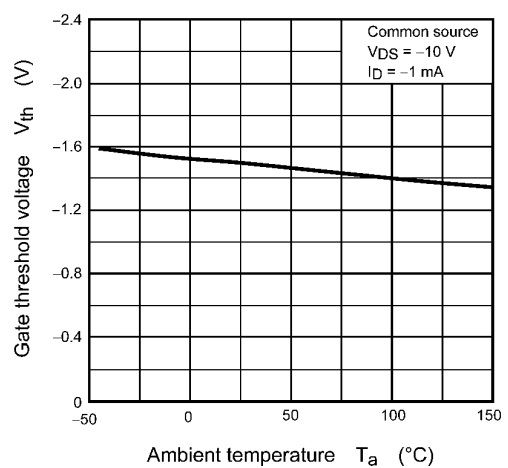
**Fig. 8.3**  $R_{DS(ON)} - V_{GS}$

**Fig. 8.6**  $V_{th} - T_a$

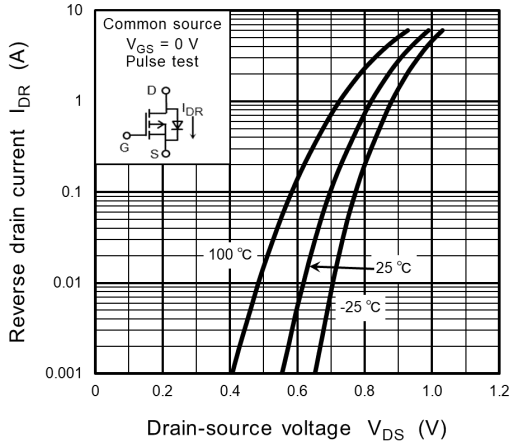


Fig. 8.7  $I_{DR} - V_{DS}$

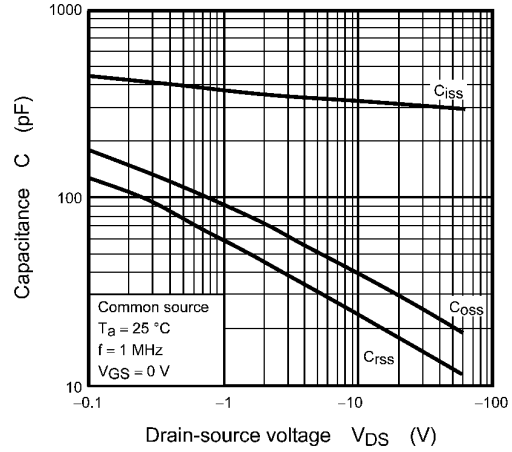


Fig. 8.8  $C - V_{DS}$

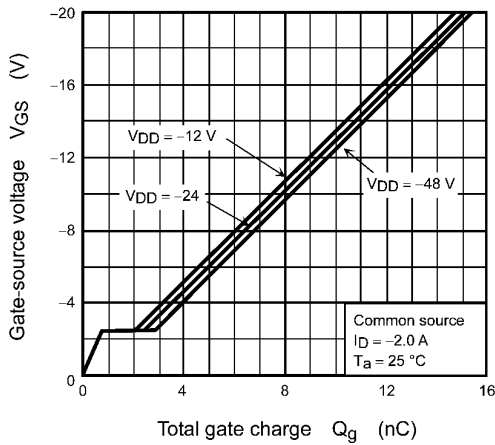


Fig. 8.9 Dynamic Input Characteristics

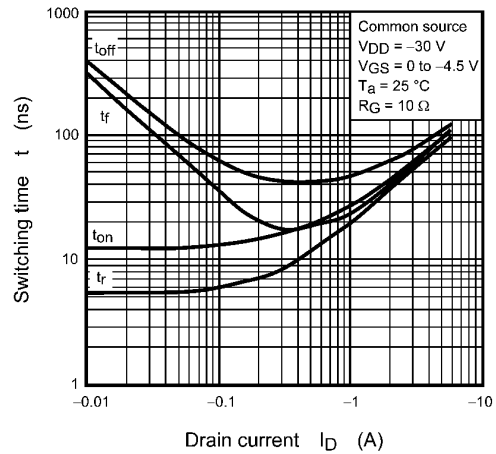


Fig. 8.10  $t - I_D$

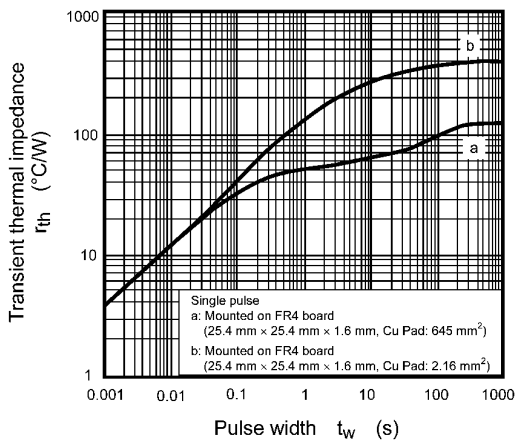


Fig. 8.11  $r_{th} - t_w$

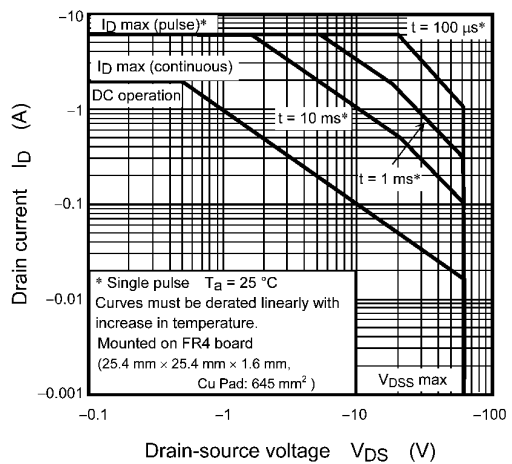


Fig. 8.12 Safe Operating Area

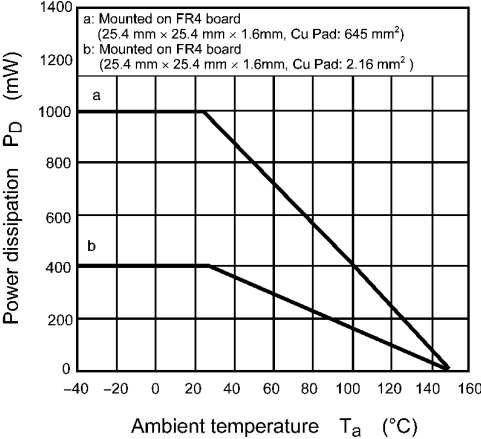


Fig. 8.13  $P_D - T_a$
