Product data sheet

1. General description

Ultra-low capacitance bidirectional ElectroStatic Discharge (ESD) protection diode in a DFN1006BD-2 (SOD882BD) leadless ultra small Surface-Mounted Device (SMD) plastic package, designed to protect one signal line from the damage caused by ESD and other transients.

2. Features and benefits

- Ultra low diode capacitance $C_d = 0.35$ pF
- High reverse standoff voltage $V_{RWM} = 24$ V
- Very small voltage dependency of the capacitance
- ESD protection up to ± 15 kV according to IEC 61000-4-2, level 4
- Qualified according to AEC-Q101 and recommended for use in automotive applications

- Protection of high-speed data lines

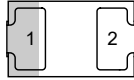
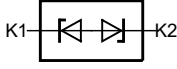

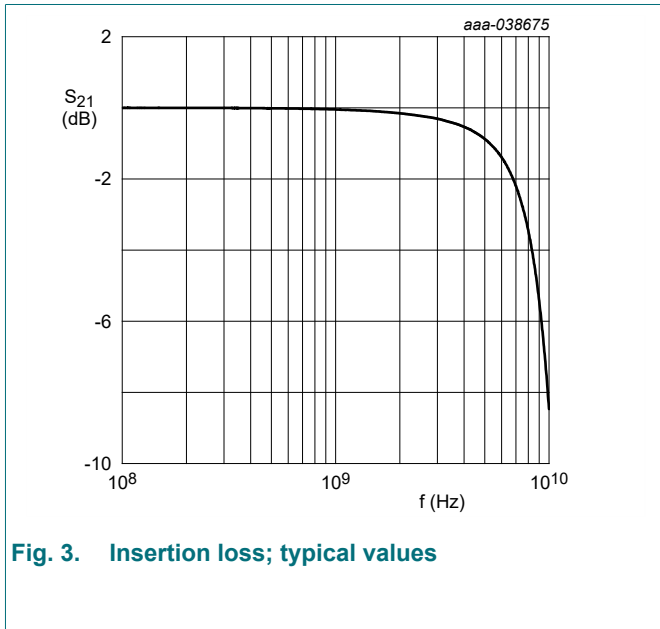


Fig. 3. Insertion loss; typical values

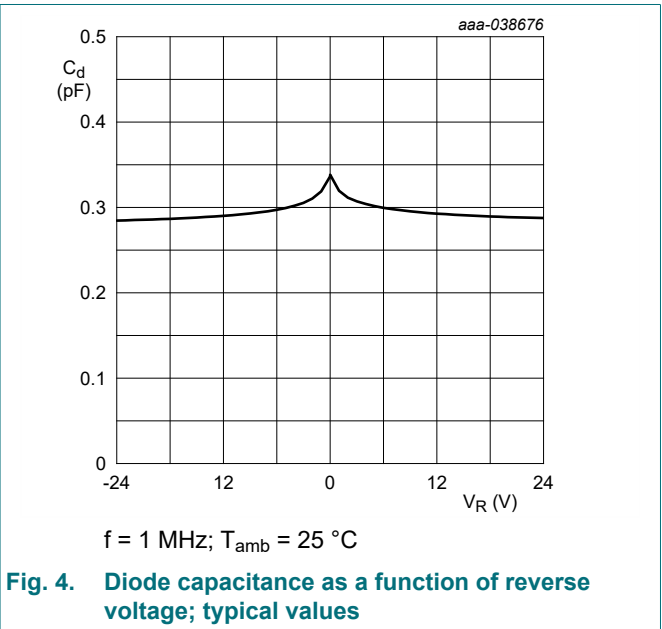
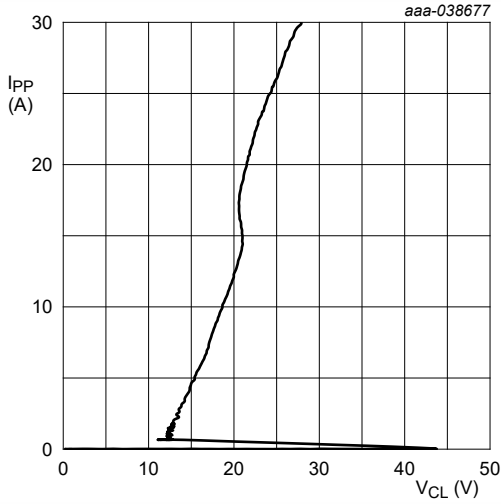
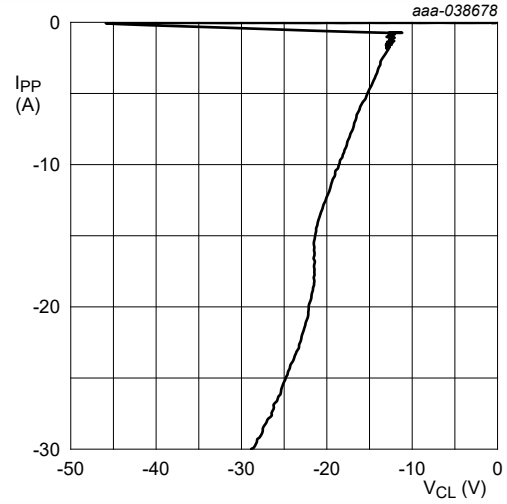


Fig. 4. Diode capacitance as a function of reverse voltage; typical values



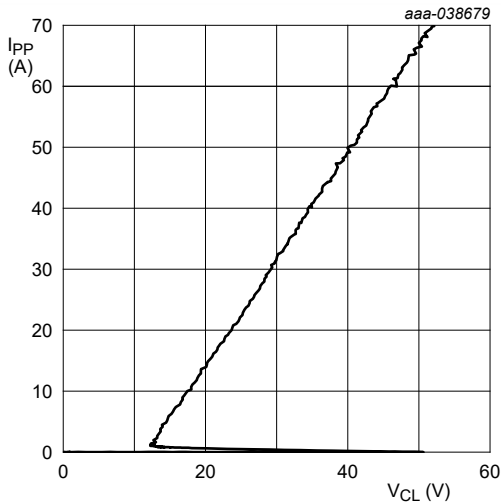
Transmission Line Pulse (TLP);

Fig. 5. Dynamic resistance with positive clamping; typical values



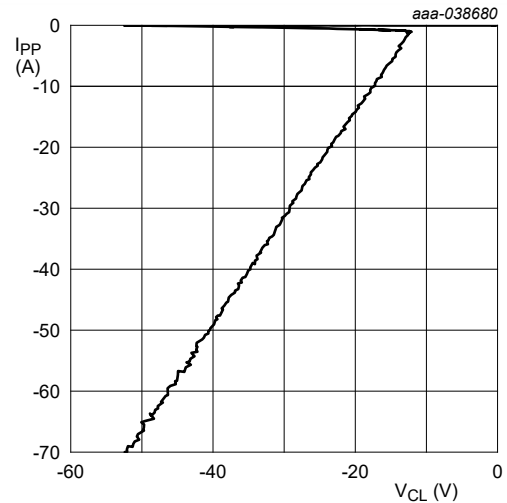
Transmission Line Pulse (TLP);

10. Application information

The device is designed for the protection of one bidirectional data line from surge pulses and ESD damage. The device is suitable on lines where the signal polarities are both positive and negative with respect to ground.

The device uses an advanced clamping structure showing a negative dynamic resistance. This snap-back behavior strongly reduces the clamping voltage to the system behind the ESD protection during an ESD event. Do not connect unlimited DC current sources to the data lines to avoid keeping the ESD protection device in snap-back state after exceeding breakdown voltage (due to an ESD pulse for instance).

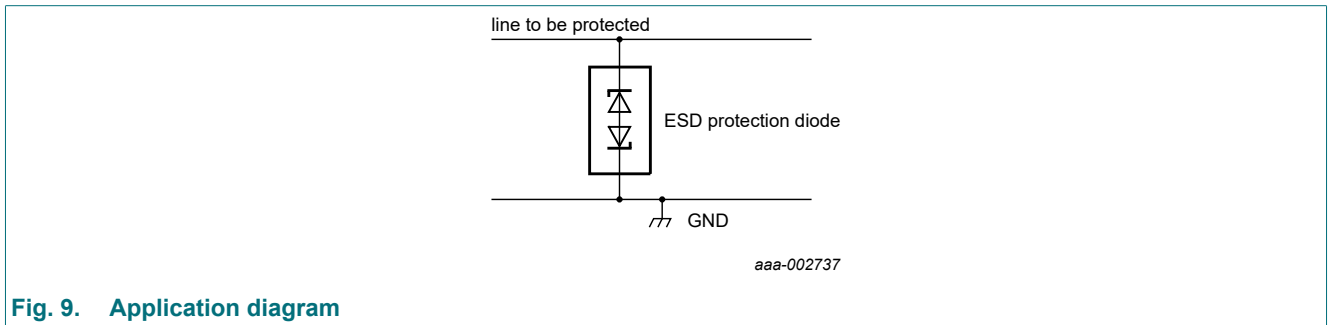


Fig. 9. Application diagram

Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

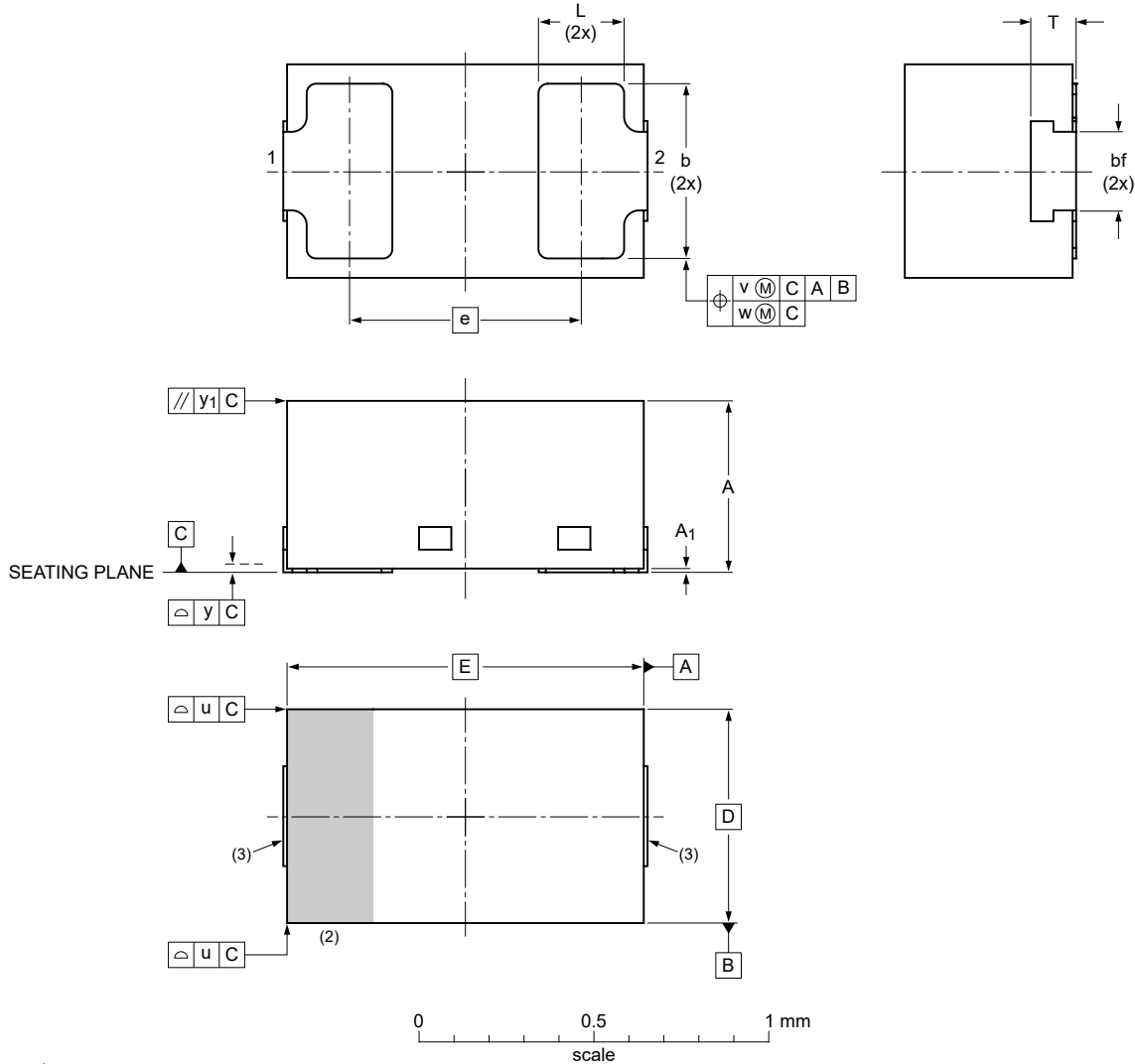

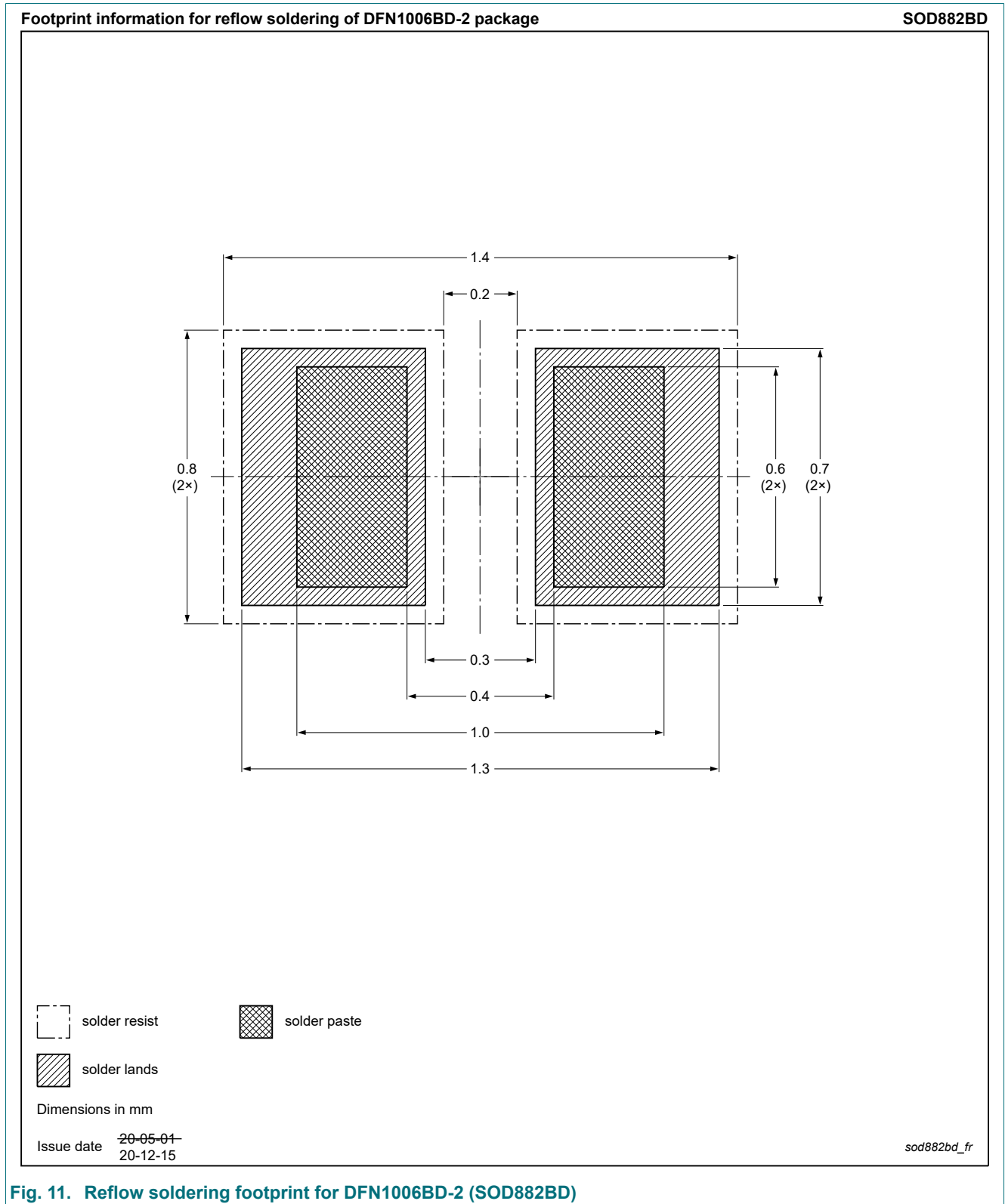
