

Typical Inductance vs. Current Characteristics:



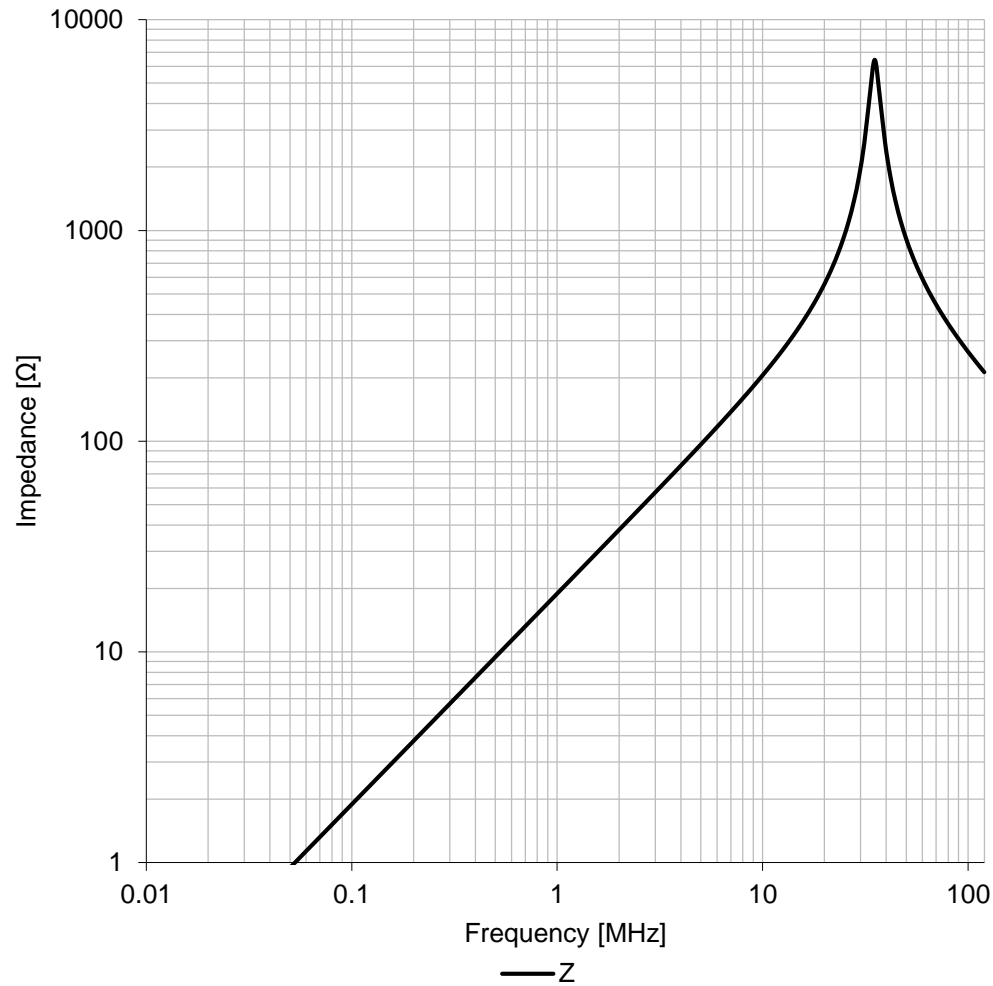
Typical Temperature Rise vs. Current Characteristics:

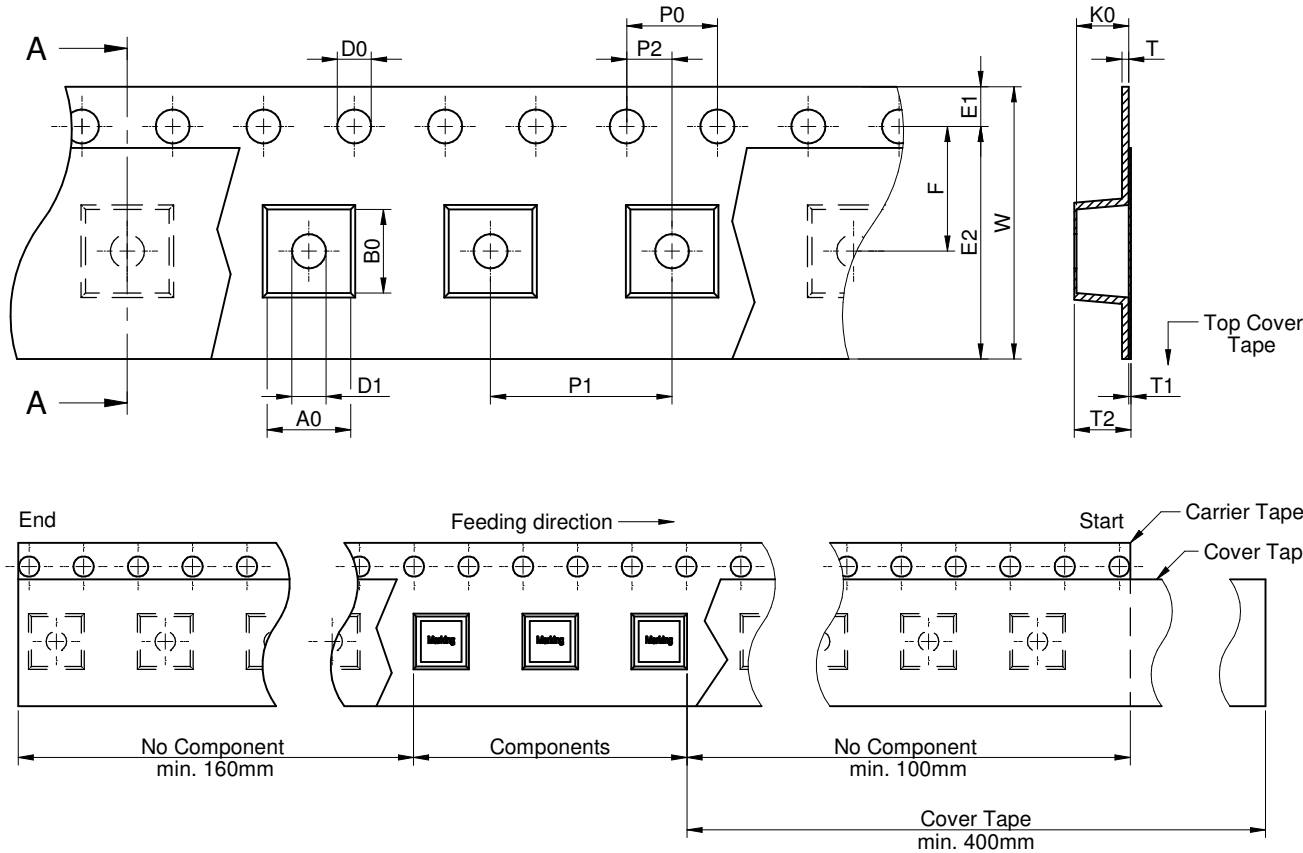

Typical Impedance vs. Frequency Characteristics:



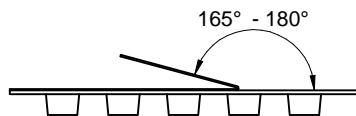



Cleaning and Washing:

Potting:



Packaging:


