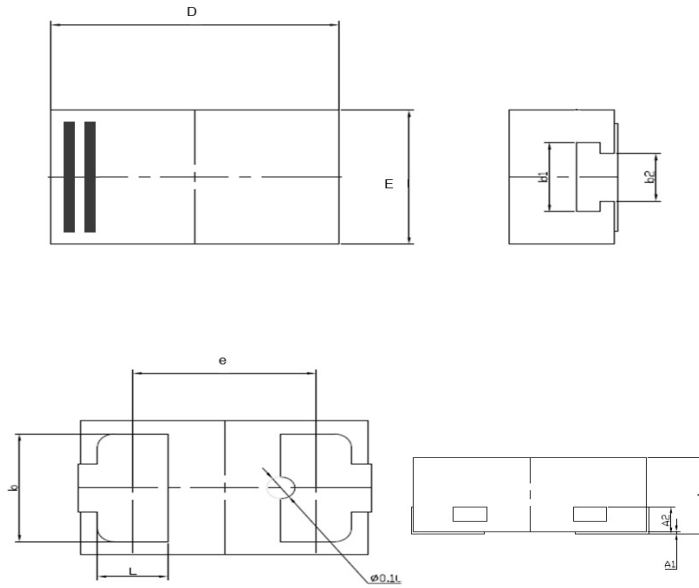
●Characteristic Curves



● Characteristic Curves

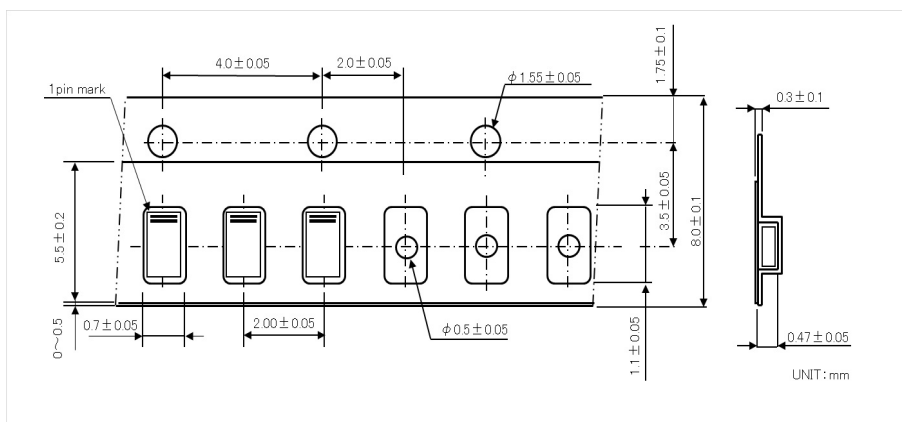
