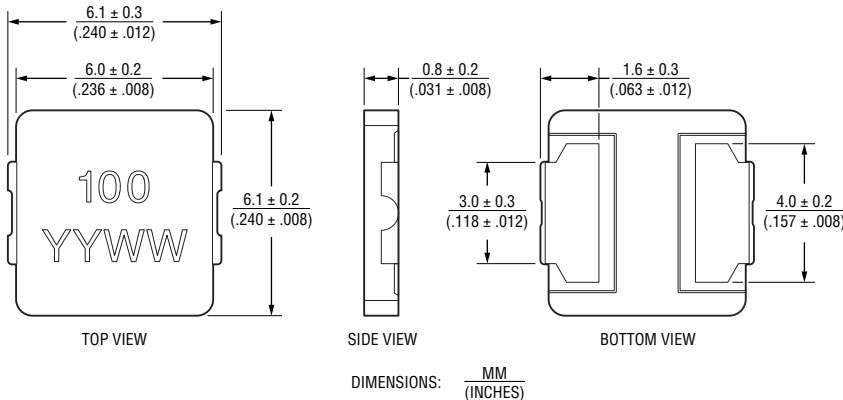

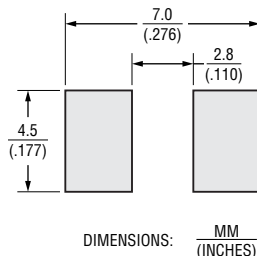

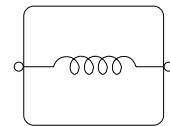

## Electrical Schematic



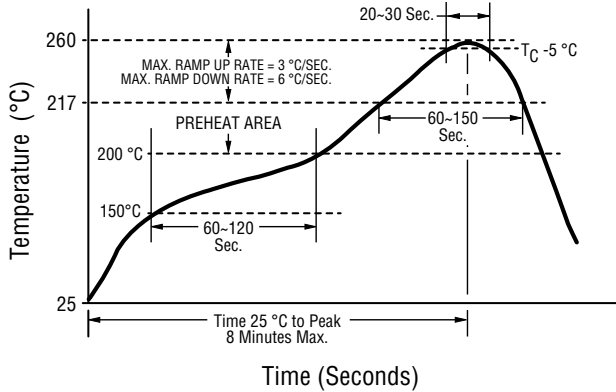
