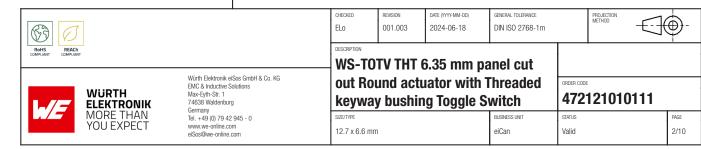


Without locking ring

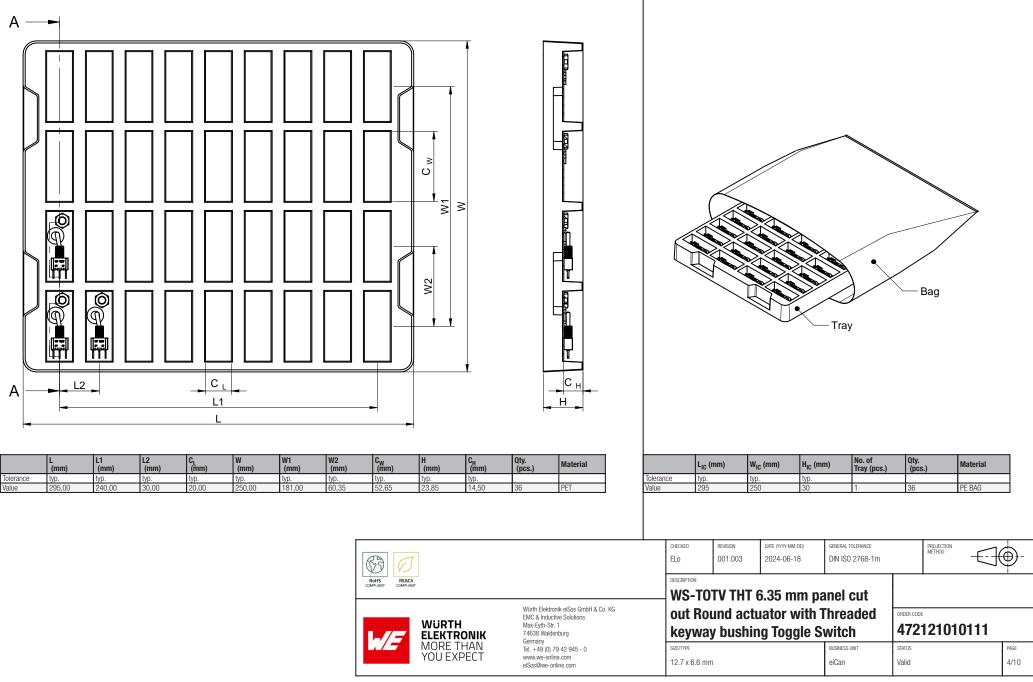

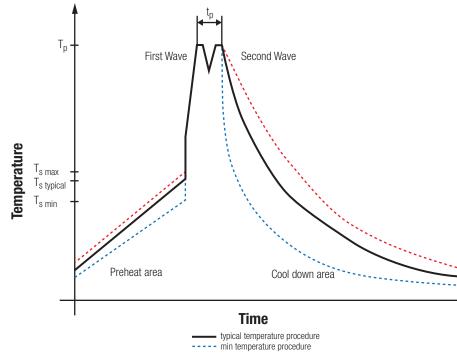
