Bostik Super Glue Easy Flow Liquid is a high strength, fast setting solvent free adhesive, which can be used for virtually any type of fastening job and bonds in seconds without the need for heat or clamps.

APPLICATION

IMPORTANT: Before using Bostik Super Glue Easy Flow Liquid refer to the relevant Health & Safety Data Sheet, available at www.bostik.com/uk.

PREPARATION

- Read all instructions carefully before use.
- Work on a protected surface as any spillages are very difficult to remove, particularly for sensitive surfaces like fabrics and skin.
- Make sure all surfaces to be bonded are clean and dry, being free from dirt and grease.
- Always point the bottle away from you when opening and don't squeeze.

APPLICATION

• Remove the cap by unscrewing it. The bottle is then ready to use.

Adhesive solutions by **ARKEMA**

- Avoiding skin contact, apply a small amount of Bostik Super Glue Easy Flow to one surface.
- Press the surfaces together and hold for a few seconds until the glue sets.
- After use, wipe the nozzle with a cloth and replace the cap. Store the bottle upright in a cool, dark place.

CLEANING

- Bostik Super Glue Easy Flow has good resistance to most oils and solvents and can be very difficult to remove.
- Bostik Super Glue Easy Flow Liquid bonds to skin very quickly and easily. Should this happen, please do not panic. Do not attempt to pull apart as this may damage the skin. If left the bond will loosen within 60 minutes without doing anything. Hot soapy water and gentle peeling will part the bond, this can take 10 minutes.
- Acetone will very slowly soften set super glue. Before attempting its use check that it is safe to use a highly flammable solvent and that the solvent does not damage the surfaces to which the super glue is adhered. Do not use acetone or solvents on the skin.
- Always test before using any solvent.

STORAGE

• Store for up to 12 months from date of manufacture when stored in original, unopened packaging in a cool, dry place 20-25°C. For long-term shortage, refrigeration (5°C) is recommended.

PRECAUTIONS IN USE

Protect work surface. Product won't work on soft plastics like polythene, or absorbent surfaces like paper. Don't use for objects that hold hot food/liquids or high-stress joints.
