Before Picture

BEFORE: The Delivery Unit (DU) was equivalent to single tube pack quantity and could be added to orders of Minimum Line Quantity (MLQ), causing repacking, scrapped boxes, and opportunity for quantity labeling errors.



AFTER: The Delivery Unit (DU) is equivalent to a standard number of tube packs, nothing repackaged per customer order. Minimum Line Quantity (MLQ) is equivalent to 1 or more DU's.



- Example: part 836119023
 - **Before:** Individual box quantity (DU) = 162; Minimum Line Quantity (MLQ) = 162
 - Result is non-standard shipping configurations in various multiples of single tube pack quantity of 162
 - **After:** New standard shipping qty = 3 tube packs of 162 = Delivery Unit of 486
 - Next available quantity above MLQ of 486 is 972 (Delivery Unit x 2)
- No impact to product, smallest package quantities, tubes, trays, or boxes

After Picture

Overview

- Parts from Molex's Tampa Bay Operations to be ordered in multiples of master carton quantities instead of tube pack quantities.
- The reason for change is for the benefit of consistent carton quantities and reducing waste of repacking, scrapped boxes, and opportunity for quantity labeling errors.
- Product Impact
 - No change to product, *no change to individual resalable package quantities or box/tube/tray sizes.*
- Part Number Impact
 - See attached impacted parts list
- PCN will be implemented once all required qualification/ validation has been completed, and all necessary approvals have been obtained.
